
Dear NvFRW Club Presidents and Members,

Some Tips on Meeting Minutes

Why are minutes of meetings important?

- Minutes are the record of decisions made by an organization, board, or committee.
- Minutes show the legal transactions/decisions of an organization.
- Minutes record what was done, not what was discussed.



CONNIE SKIDMORE

Who records and keeps the minutes of an organization?

The Secretary/Recording Secretary/Clerk/Scribe/Recorder. The Secretary should maintain a file of completed and approved minutes so members may review and refer to them.

In the absence of the Secretary, the President or Chairperson should appoint a pro tem to take the meeting minutes.

What is the format for minutes?

Heading and first paragraph: Name of organization, type of meeting (regular, special, or adjourned), location, called to order by whom, action taken on minutes of the previous meeting(s) – approved as written, read, or corrected.

Body of Minutes should include:

- (1) Reports of officers (at least the Treasurer's report), Standing Committee reports any special committee reports.
- (2) All motions/resolutions passed or failed (with drawn motions do not go in the minutes). State the name of the motion maker; it is not necessary to mention the seconder.
 - (a) Final wording of all main motions (with any amendments).
 - (b) All points of order and appeals, noting whether sustained or lost and giving the Chair's reasons for the ruling.
 - (3) Announcements
 - (4) Adjournment time
 - (5) Signature and title of recorder of the minutes.

Note: It is no longer necessary to use the words "respectfully submitted" at the end of minutes. The person writing the minutes should only put their name at the end and title.



Famous Women of Nevada Anne Henrietta Martin (1875-1951)

Anne Henrietta
Martin was a leader
in promoting the
passage of the
women's suffrage
amendment, serving
as the chair of the
Nevada Equal Franchise Society. Ms.
Martin was head of
the history department of the Univer-



sity of Nevada (1897-1901) and the first national chairman of the National Woman's Party in 1916.

In her efforts to obtain suffrage, she organized branches in every county, resulting in ultimate triumph when the Nevada Constitution was ratified in 1914, followed by the passage of the 19th Amendment in 1920. She was also the first woman to run for U.S. Senate in Nevada, although she lost in both 1918 and 1920.

An interesting aside is she was arrested in 1910 trying to enfranchise British women. A friend from her Stanford days, whose husband was one, Herbert Hoover, enlisted Herbert to pay Martin's bail, although another friend had already posted her bail before he could act.

We owe a great debt of gratitude to those women who blazed a trail for the rest of us. In the future, historians will hopefully recognize our great organization as an instrument of change in Nevada.



Question:

When is a yes vote on a "bad" bill the right vote?"



Answer:

When a legislator is willing to sacrifice themselves on the altar of Amendments.

By Barbara Kirk, NvFRW Treasurer pending their time, effort, and political capital to create and negotiate acceptance of an amend ment that makes a bad bill less bad often has negative consequences for the initiating legislator.

When an amendment is made, it is required that the creator of that amendment vote *yes* on the bill. When the deck is already stacked in favor of the *bad* bill, then one more *yes* vote is immaterial but necessary. Many times, these legislators receive bad press for voting in favor of the *bad* bill with no mention of the reason or the amendment.

They sometimes are labeled RINOs because people are too lazy to do the research or ask questions. This decision can also negatively impact their voting statistics.

Think for a minute. Most of us offer our support to legislators that continually vote *no* on bills that we would consider *bad*. Not only do we support them we often Idealize them. A no vote on a *bad* bill is great and appreciated, but consider that, in part, it might be an easy, effortless way to legislate. So, in the future, ask more questions, do your research, and give credit to legislators willing to sacrifice their reputations for the greater good of all Nevadans.

CONTINUING SAGA OF THE ELEPHANT LOGO'S STARS



We received a response to the question I mentioned in the last issue of this newsletter. WHO, WHEN, AND WHY were the stars on the GOP elephant turned upside-down? It piqued the curiosity of one of our readers, who sent me this informative email with links to some answers.

I could not resist looking up your question about why the stars on the elephant logo are upside down. Check these out. "Why were the stars turned upside down in the Republican Elephant in 2000?" This Bing video explains the star concern.

Thanks, Kathryn; this research disproves some of the below-noted myths surrounding the change.

A Few of the Theories

- The GOP made a deal with the devil, and the inverted stars represent a pentagram!
- When a country is in distress, its flag is flown upside down—thus the change in the stars' direction
- Some college intern graphic designers did it for fun to see if anyone would notice.

As a result of the research Kathryn found, we can rule out that the change came in 2000. Several campaign logos and election buttons well before the emergence of Bush Jr. show the stars upside-down. See examples on the website: Political Pistachio: Study of the GOP's Upside Down Stars (above).

Further, the change of the direction of the stars did not happen randomly or covertly. According to U.S. Trademark Applications and Registrations Retrieval database, it was issued Trademark No. 1908397 filed in 1993, and registered in 1995. First use date is 1969 and it appears on the '72 Republican Convention rule booklet, complete with upside-down logo stars. Thus debunking the the unoticed graphic error theroy.

Federal Aviation Administration, Defense Logistics Agency and the Marine Corps in construction management and environmental engineering. She moved to Carson City with her family in 1998 and raised her two children there.

Christine got involved with the Republican party when she turned 18 and could vote for her first president, President Ronald Reagan. She has been involved in Republican politics ever since, realizing how important being involved at the local, state, and federal levels.

Christine is a Past Co-President, Woman of the Year, and the Americanism Chair of the Carson City Republican Women, the Northern Chaplain for the Nevada Federation of Republican Women twice and is currently the President of the [newly chartered] Ormsby Republican Women's Club. MEET MISSY DAY PRESIDENT



s we continue in our quest to get acquainted with the presidents of our 19 Women's Republican Clubs, NvFRW's leader Caroline Smith urged me to do an article on Missy Day of the Republican Women of Las Vegas (RWLV). It turned out to be a very interesting interview.

Missy was born in Long Beach, California, and raised in nearby Bellflower. She attended college in Oregon, where she met her husband at church. She remained living in Oregon for 15 years. In 1993 the couple relocated to Las Vegas and will celebrate their 40th anniversary this November. Missy enjoys traveling and reading in her free time and recommends a favorite book to fellow conservatives, The 5 Levels of Leadership: Proven Steps to Maximize Your Potential by John Maxwell. It is directed toward working as a team.

Missy grew up in a Democrat party household except for her father. When she turned 18 and was preparing to register to vote, he asked her, "You are going to be a Republican, aren't you?" Of course, she said yes, and proceeded to join the Republican party, where she has remained a member ever since. She speaks fondly of having had the opportunity to work on Ronald Reagan's campaign in California.

She served as the president of the NAWBO—National Association of Women Business Owners and joined a Republican women's group in 2018. The RWLV group had been around for 75 years and once boasted 150 members. Unfortunately, the club's size had dwindled, and when the entire board termed out after serving their four years, it became a sink or swim situation.

In 2021 the then president Saroj Singh approached Missy with an earnest plea. "Missy, if you don't step up and become president, this group may cease to exist." York City on September 11, 2001. But "nor malcy," as we knew it, was about to change. At 8:46 a.m., the first plane hit the World Trade Center. (A film crew nearby filming something else turned its camera toward the WTC, and within three minutes, the Associated Press picked it up, sending it nationwide.) Three other planes were intentionally crashed that morning, including one in a field near Shanksville, Pennsylvania. The target of Flight 93 will never be known. It may have been the White House, the U.S. Capitol, Camp David, or one of the nuclear plants along the East Coast.

As the collapse of the second tower began it took only 10 seconds to fall. After the first plane hit Tower 1, the people in Tower 2 tried to evacuate but were told to stay at their desks. Those who tried to leave were held back by security. The ages of the victims ranged between two and 85. Almost 85% were men. Over 100 Search and Rescue dogs were deployed to help find survivors in the rubble.

The attacks killed 2,996 people; 400 were emergency personnel. Over 6,000 were injured. As of August 2017, 60% of the WTC victims' remains have been positively identified, leaving 1,113 with no biological confirmation of death. At least 200 people jumped from the towers. These deaths were ruled—not suicide but homicide at the hands of terrorists.

Osama Bin Laden, the al-Queda leader, was the mastermind behind it and the 19 men who carried it out were mostly from Saudi Arabia. The hijackers' ages ranged from 20 to 33. It is estimated it cost \$500,000 to carry out the attack. It took ten years to finally take out Bin Laden. At the time of his death, a \$25M bounty was out for him.

The attack caused about \$10B in infrastructure and property damage. The cost of clean-up was \$750M. The 41.8M tons of debris took 3.1M person-hours and was finished in May 2002. More than 1,110 people who worked or lived near the WTC at the time have been diagnosed with cancer due to exposure to toxins from the site. Asbestos, printer cartridges, smoke, jet fuel, and many other carcinogens have caused severe health problems.

Most of us remember where we were and what we were doing that fateful day, as the news spread worldwide. September 11, 2001, is a solemn reminder that even the strong, free nation we are cannot be untouched by hatred and destruction. It is believed the attacks were:

- A protest against America's support of Israel.
- Our participation in the Persian Gulf War.
- The ongoing military occupation in the Middle East.

Although not a national holiday, September 11 is commemorated as *Patriot Day* in honor of all those who died that day.

Labor Day: More than Just a Day to BBQ

What do you think of when you hear Labor Day? That it marks the end of summer, time for your last big pool party, cook-out, or day at the lake, maybe even the last day to wear your white shoes?

Most of us don't even recall that the first Monday of September is a day rooted in the opposite atmosphere of the festivities we celebrate today. However, on September 5, 1882, over 10,000 NYC workers took to the streets and marched from City Hall to Union Square. This unofficial parade honored all the US workers who labored long hours under the harsh conditions of the time. Factories were often unsafe; workers were severely underpaid, and even young children were sent to work on the factory floor to earn wages to help support their families. The deplorable conditions led to anger and resentment. There were uprisings and violence – both inside and out of the factories.



While the creation of labor unions helped to alleviate the terrible conditions that inspired the violence, workers still felt the need for more. So, when those 10,000-20,000 workers in NYC took unpaid time off on that day in 1882 to march to honor the American worker there was fear that things could turn into a disaster. Instead, the parade, was filled with music, laughter, flags, and badges, ended with a picnic that drew even more people. This peaceful protest was a bright spot that caught the attention of legislators and workers alike.

By 1885, several states had considered legislation for an official "labor day," and in 1894, Congress declared the first Monday of September a national legal holiday.

early two centuries ago, visionaries such as Horace Mann and John Dewey brought forward the concept of government providing a public school system paid for by tax dollars. The goal was that every American child would be able to get a basic core education in reading, writing, math, science, and history and thus become a productive member of society.

Unfortunately, America has, over several decades, pushed out much of our core education and replaced it with content that is intended to indoctrinate our children. The powers that be understand that what we teach our children is vital to defining what kind of country we are. As the direction of our nation becomes more of a political struggle, those who have charge over our schools are seeking to create a nation that reflects their goals and values. We see that now in full force. Parents are kept at bay while the teachers' unions, university education departments, and the state legislatures and bureaucracies fill our children's heads with social justice, racial justice (Black Lives Matter), environmental justice, and way-too-young sexualization of their bodies. We must push back on this.


It is true. As goes our children so goes our nation. A secondary but also distressing result of the piling on of all these politically-charged materials is the amount of pressure it heaps on teachers. Even if they want to meet the educational needs of their students, there simply isn't enough time to educate them in the basic core subjects. How schools are currently handling discipline, which is also part of the political maneuvering, is a huge hurdle. The issue of being able to control the students in the classroom

has reached a crisis level because of burdensome responsibilities assigned to teachers regarding disruptive students. The far left's insistence through the Nevada Legislature on Restorative Justice (or Restorative Practices as it is called in the policy our school district adopted) has taken the sting out of consequences for actions.

Ironically, research shows that school administrators and other staff have fared far better in getting higher salaries than those we charge with educating our kids. I am of the belief that teachers deserve more respect and support – and pay. If our superintendent is to be paid \$166,000 a year plus benefits, then I think that teachers, being on the front lines, should be supported much more.
